MESSAGE FROM THE CHAIR



As the new chair of the board of directors of the Canadian Institute for Research on Linguistic Minorities (CIRLM) effective January 29, 2018, I am pleased to present the 2017-2018 annual report. It is with pride that I assume this new role previously occupied by Dr. Raymond Théberge, for whose commitment and dedication to the Institute we are all grateful.

On the eve of the renewal of the federal government's action plan for official languages, the Institute's mandate and mission remain as important as ever with respect to the development and updating of our knowledge about official-language minority communities (OLMCs). Through its expertise, the CIRLM assists public policy leaders and community groups in supporting their respective evidence-informed strategic planning processes based on reliable studies. It also serves as a knowledge hub concerning OLMCs driven by its team, network of research partners and various online tools referring and distributing research on these communities.

Over the last year, a number of changes have been made to the presentation of the research agenda setting out the CIRLM's various activities and projects. The Institute's activities are now organized into five focuses that touch upon multiple sectors (health, education, culture, immigration, etc.): 1) populations living in minority communities; 2) community development; 3) politics, influence and governance; 4) language rights, recognition and legitimacy; and 5) memory, identity and diversity. Additionally, a new five-year strategic plan was adopted in 2017 in which the Institute seeks to promote knowledge mobilization activities with a greater focus on research partnerships and comparative research while maintaining the continuity of the expertise accumulated over the course of its 16-year existence.

In this report, you will note that the CIRLM is involved in a wide range of projects reflecting both the cyclical (particularly based on analysis of data from the last census) and the transitional needs of the study sponsors as well as independent research themes. They also reflect the team's capacity to mobilize researchers around research themes that are relevant for OLMCs. Lastly, they support development of the next generation by involving junior researchers in the projects conducted. Space does not permit listing all of them here, but these studies cover a variety of OLMC issues and sectors, from projects on health involving analysis of the effectiveness of language laws or food insecurity among Francophones in the Maritimes to studies of French-language services, demolinguistic data in education, identity and cultural issues – through projects such as "L'état de l'Acadie" – places of public memory and cultural industries. In Quebec, the Quebec English-speaking Communities Research Network has taken part in a number of activities and events, organizing a colloquium on 40 years of Bill 101, forming the Inter-Level Educational Table and participating in the consultation activities of the new secretariat for relations with English-speaking Quebecers established in 2017 in Quebec.

Looking back at the work accomplished in particular by the CIRLM's executive director, Éric Forgues, and his team to add to people's knowledge about OLMCs, I take this opportunity to commend them on their achievements and encourage them to continue promoting research in this area.

MOT DU DIRECTEUR



In 2017, the Canadian Institute for Research on Linguistic Minorities adopted a new five-year strategic plan that, while continuing to promote research that is socially relevant for official-language minority communities (OLMCs), also aims to take us to the next level in the area of knowledge mobilization with a view to more effectively contributing to social innovation within OLMCs. In today's increasingly complex societies, decision makers and stakeholders need to acknowledge the important role of research, which must serve to support the development and implementation of public policy as well as the community planning exercises undertaken by OLMCs. The effectiveness of key actors' efforts depends on this, and, ultimately, the fate of our OLMCs is what is at stake. The fact that the 2018-2023 Action Plan for Official Languages provides for achievement of evidence-informed objectives is reassuring and promising for the years to come.

In terms of research, the 2017-2018 year stood out in particular for the development and implementation of a number of ongoing projects. The Institute's research partners initiated their activities under the auspices of the project "L'état de l'Acadie" involving 100 or more researchers responsible for analyzing the current situation with respect to a diverse range of sectors and issues related to Acadia. This unifying project is made possible through support from a long list of partners. An editorial committee made up of Dominique Pépin-Filion, Michelle Landry and Julien Massicotte is overseeing the assembly of this collective reference work with assistance from a dozen or more expert contributors addressing the various themes identified. At the same time, Anne Robineau has continued her activities under an SSHRC-funded project on the cultural and creative economy among English-language cultural professionals in Quebec. In the next phase of this project, she is launching a study of cultural industries through an analysis of the Acadie Rock Festival. She has also started a highly timely project on the impact of the digital culture on the Canadian Francophonie. Meanwhile, we are completing the data analysis phase of the project on the incidence of food insecurity among Francophones in the Maritimes. The team I am leading under another SSHRC-funded project, on places of public memory and the Acadian and Cajun identity, has completed data collection and entered the analysis phase. Under a project funded by the Consortium national de formation en santé on the effectiveness of language laws, we are continuing to collect data in hospitals as part of a process that has proved longer and more challenging than expected. The reticence we have encountered clearly highlights the relevance and importance of research into institutional health services in French.

In addition to these independent research projects, we are carrying out sponsored projects for a number of organizations, among them the Commissioner of Official Languages (on Francophone space), the Commissioner of Official Languages for New Brunswick (demolinguistic data), the French-Language Services Commissioner of Ontario (Francophone immigration), the Société de l'Acadie du Nouveau-Brunswick (exploratory study concerning a centre for social innovation in Acadia), the Fédération de la jeunesse canadienne-française (identity construction) and a Francophone school board (demolinguistic data). Josée Guignard Noël is leading several of these projects in addition to meeting ongoing needs with regard to statistical data analysis for law firms. We have also submitted a report to the Alliance nationale de l'industrie musicale proposing to offer more training to artists and entrepreneurs.

In Quebec, Lorraine O'Donnell and Patrick Donovan have continued to coordinate the Quebec English-speaking Communities Research Network. They organized the conference Bill 101 at 40: The Charter of the French Language and Quebec English-speaking Communities, 1977-2017. They participated directly in the establishment of the Inter-Level Educational Table bringing together representatives from English-language educational institutions, community groups and the public sector. They are currently planning the Table's first community forum, on the vitality of minority communities through education, which takes place on October 28 to 30, 2018. They have also established ties with the new secretariat for relations with English-speaking Quebecers created in 2017 in Quebec.

This past year, researchers at the Institute also took part in a number of consultation activities conducted by the government, including Statistics Canada. These included a consultation led by the Treasury Board in a context in which the government is seeking to renew the Official Languages Regulations; a consultation of the Standing Senate Committee on Official Languages, which is conducting a study on modernizing the Official Languages Act; and, finally, membership on a new committee formed by Statistics Canada on language variables. Working with the team at the firm Power Law, Rodrigue Landry submitted a report to the Standing Committee on Official Languages concerning recommended changes to the census questionnaire to arrive at a more accurate count of rights holder parents. The conclusions of that report were set out in the Committee's report and subject to discussion at the first meeting in January 2018 of the Statistics Canada advisory committee on language variables.

Edited by Réal Allard, the journal *Linguistic Minorities and Society* published two issues this past year: issue 8, published in the summer of 2017, was a varia, i.e. non-thematic, issue featuring articles on a range of topics including the quality of

French in Acadia, ethnocultural diversity in Francophone schools in the minority Acadian context, place identity construction in teenagers in New Brunswick, Francophone parent couples in minority communities and self-devaluation among Francophone Quebecers. That issue also contains 10 book reviews. Issue 9 was published in March 2018. This is a thematic issue under the title "Youth Mental Health in Official Language Minority Communities (OLMCs) in Canada: Situation Analysis." Some of the articles in this issue are historical in nature, but the majority focus on analysis of youth mental health in minority Francophone communities as well as in Quebec's Anglophone community. This issue also features five book reviews. Four new thematic issues are currently being planned. The working titles of these issues are: "Retour sur la question du pouvoir dans la francophonie canadienne"; "Relations, pratiques et représentations de l'inclusion dans les communautés francophones en situation minoritaire"; "Inclusion, exclusion et hiérarchisation des pratiques langagières dans les espaces plurilingues au 21^e siècle et Anglophones" and "The English Language and the Creative Economy of Montreal: Connect and Disconnect."

The preceding is just an overview of current and upcoming activities at the Institute. The 2017-2018 annual report that follows explores the Institute's achievements during the past year in greater detail. I take this opportunity to thank the entire team for their dedication to their work and to research on OLMCs as well as all the research partners and research assistants who contribute to the Institute's success. In particular, I would like to thank Joannie LeBlanc, who has worked for four years as a research assistant on many projects at the Institute. Special thanks also to our administrative assistant, Azure René de Cotret, for her outstanding work in maintaining the efficiency of the administrative operations of the Institute and the Linguistic Minorities and Society journal and her vital role in formatting the many documents produced by the Institute and in updating and making ongoing improvements to the Institute's website.



INTERNET

CIRLM has launched its new website in December 2014 (www.icrml.ca) and has been reconfigured to improve the user's browsing experience and make accessing information easier. CIRLM would like its website to be a user-friendly tool for those interested in research on official language linguistic minorities in Canada. From April 1, 2017 to March 31, 2018, the CIRLM website had approximately 8663 visits of which 86% were new visits.

Also the CIRLM website has a directory of researchers on Official Language Minority Communities (OLMC) including a registration form (there are currently 125 researchers). This section is regularly updated. CIRLM also added a directory of research teams, groups, centres and institutes on OLMC.

To promote its events, the CIRLM sends regular newsletters to members on its mailing list (currently 476 subscribers as of March 31, 2018. As another means of communication, the CIRLM created a Twitter account (@ICRML_CIRLM). This social networking tool enables the CIRLM to send instant news updates. Created in June 2012, the CIRLM's Twitter account now 468 followers. A Facebook account was also created in May 2016 (www.facebook.com/ICRMLCIRLM).

As well, the CIRLM has a bibliographic database, accessible online through the CIRLM website, with 5,813 references. This database is regularly updated.

As for QUESCREN, it has its own website (<http://www.concordia.ca/artsci/scpa/quescren.html>) and continued to add titles to its online annotated bibliography of publications on Quebec's English-speaking communities (compiled by volunteer Brendan O'Donnell). Total number of titles: 11 494 as of February 2018.

QUESCREN produced English- and French-language newsletters in April, July and October 2017 and February and also sent out two additional brief updates with invitations for events. The newsletter provides subject-level access to news on publications, projects and events related to ESCQ research. Diffusion to 750 recipients as of February 2018.

Lorraine O'Donnell, coordinator-researcher of QUESCREN, and Patrick Donovan, associate coordinator, are responsible for research, coordination, administration and management of this research unit. They also participate in CIRLM activities (staff meetings, Program Committee meetings) and in activities at Concordia University, where QUESCREN is situated.

Since September 2015, Lorraine O'Donnell is Affiliate Assistant Professor in Concordia University's School of Community and Public Affairs.
