

## MESSAGE FROM THE CHAIR



As Chair of the Board of Directors, I am pleased to present the 2020–2021 annual report of the Canadian Institute for Research on Linguistic Minorities (CIRLM). Despite the context of the pandemic and its impact on research activities, the researchers of the CIRLM have succeeded in conducting analyses with data from Francophone Minority Communities and Quebec Anglophone communities. Some research projects were underway prior to the pandemic, whereas others were initiated during the pandemic, affecting certain activities such as the pace of data collection. However, faced with this exceptional situation, the CIRLM team adapted and demonstrated great innovation, which is reflected in the results presented in this report.

Over 12 research projects were implemented by the CIRLM team and several others have been completed. They are divided into five research areas: 1) populations living in minority communities; 2) community development; 3) politics, influence and governance; 4) language rights, recognition and legitimacy; 5) memory, identity and diversity. Among these, several provide sociodemographic and demolinguistic portraits, such as those on migration trends and on allophone immigrants in Official Language Minority Communities (OLMCs). Parallel to this, a broader reflection on the linguistic variables used to define a “Francophone” and an “Anglophone” has also been carried out within committees that include members of the CIRLM.

Some projects deal with language rights, such as the one on the connection between the understanding of these rights and the active offer of health services, or the project on the publication of the issue of *Minorités linguistiques et société / Linguistic Minorities and Society*, which was devoted to the 50th anniversary of the *Official Languages Act*. Other projects analyze the role of certain organizations in the development of minority language communities more specifically. This is the case for two projects on youth organizations, one on their collective action in New Brunswick, the other on the national network and its impact on the personal and professional development of young Francophones who have been involved in it for 50 years. In addition to these projects, others expand on the study of the cultural and identity dimension (memorial events, cultural policies, digital technology and the diversity of cultural products) of OLMCs.

Finally, it is important to note that all of these projects, in addition to being a team effort within the CIRLM, are also an opportunity to train students, strengthen the network of researchers associated with the CIRLM and build bridges between the scientific environment, the community and OLMC policy and program managers. Thus, the collaborations and partnerships developed by the members of the CIRLM make it possible to meet the needs of OLMCs by relying on evidence that is relevant to their development. For this, I would like to thank Mr. Éric Forgues and his team for their contributions to improving knowledge and identifying the challenges and aspirations of minority language communities.

## MESSAGE FROM THE EXECUTIVE DIRECTOR



Another busy year has passed for the CIRLM, a year marked by the context of the pandemic, but also a year when the word “adaptation” surely became the one to remember. There is no doubt that although such an environment can bring its share of challenges, the CIRLM team quickly adapted to the situation.

The enthusiasm and commitment of the team have remained the same while working on several projects and participating in virtual research activities. On the research front, we have conducted or are currently conducting projects sponsored by community and government organizations on issues such as language rights in the health sector, the 50th anniversary of the *Official Languages Act*, and supporting Francophone researchers in Canada.

Over the past year, we have had the opportunity to work on the theme of Francophone youth in Canada. A first project that was completed over the course of the year dealt with the evolution of the Fédération des jeunes francophones du Nouveau-Brunswick (FJFNB). We then initiated two other projects with the Fédération de la jeunesse canadienne-française (FJCF), one of which evaluated the impact of the Vice-Versa program’s community-based school projects, and the other the impact of the “BY Youth, FOR Youth” philosophy within the Canadian Francophone youth network.

In addition to these activities, we continue to work on projects funded by the Social Sciences and Humanities Research Council (SSHRC) on the Congrès mondial acadien (CMA), English-language arts and culture in Quebec, and on the identity dimension of cultural events in minority environments.

Due to current circumstances, we have had to postpone the publication of *L’état de l’Acadie*, which will be released in the spring of this year. This highly-anticipated book will report on the situation and issues in various sectors of contemporary Acadie.

In working on our projects, the word “adaptation” has also meant that we cannot ignore the context of the pandemic and its impact on society. As a result, for some of our current projects, it has been unavoidable to include this aspect and even adapt data collection.

Although research funding has been difficult in recent years, we have been able to carry out research projects and take part in virtual events over the past year. Nevertheless, participation in various conferences had to be postponed or cancelled. We were forced to postpone the conference *Heritage, Memory and Vitality of Linguistic Minorities* planned for the 2020 Acfas Congress to 2021, because Acfas was obliged to cancel its annual event.

We also continue to work on the academic journal *Minorités linguistiques et société / Linguistic Minorities and Society*, which published its thirteenth and fourteenth issues last year, the first one having more varied articles, and the second one addressing the policies, representations and practices of inclusion in Francophone Minority Communities (FMCs). I would like to thank Réal Allard for his excellent work as director of this journal. I would also like to acknowledge the Consortium national de formation en santé (CNFS) for their support of the journal.

In the Presses de l'Université Laval (PUL) *Langues officielles et sociétés* collection, which Anne Robineau and I codirect, the year was devoted to the preparation of three books that will soon be published.

The CIRLM continues to collaborate with the Quebec English-speaking Communities Research Network (QUESCREN), which is coordinated by Lorraine O'Donnell and Patrick Donovan. The CIRLM team is currently working on the publication of texts from the symposium on the 50th anniversary of the *Official Languages Act*, as well as on the organization of the *Heritage, Memory and Vitality of Linguistic Minorities* conference. Moreover, the relationship with the QUESCREN is also of an administrative nature: a QUESCREN representative sits on the CIRLM board of directors, while a representative of the CIRLM sits on the QUESCREN advisory board.

Since its inception, the CIRLM has sought to foster the training of students and new researchers by integrating them into research projects, while offering them the opportunity to develop or improve their knowledge and skills on Official Language Minority Communities. In the past year, we have hired and worked with five research assistants from different areas and graduate levels.

I would also like to welcome the new Université de Moncton President, Mr. Denis Prud'homme, who will act as chair of our board of directors.

It is with great pleasure that I present our annual report for 2020-2021, in which you will find the projects in progress and the publications produced by our team with the invaluable assistance of our associate researchers, which attest to the efforts of our Institute to achieve its objectives and accomplish its mission.

We will continue our efforts to raise awareness of OLMC research and pursue its development.



## INTERNET

In 2014, CIRLM website ([www.icrml.ca](http://www.icrml.ca)) has been reconfigured to improve the user's browsing experience and make accessing information easier. CIRLM would like its website to be a user-friendly tool for those interested in research on official language linguistic minorities in Canada. From April 1, 2020 to March 31, 2021, the CIRLM website had approximately 9 564 visits of which 87,3% were new visits.

Also the CIRLM website has a directory of researchers on Official Language Minority Communities (OLMC) including a registration form (there are currently 125 researchers).
